Position Summary

Operates dump truck and hauls gravel and asphalt construction jobsites in the Sioux Falls area. This position will require ownership in keeping the dump truck box clean at the end of the day.

Essential Duties and Responsibilities

- Start, warm up, cool down and shut down a dump truck.
- Perform basic maneuvers and basic earth compacting operations with a dump truck.
- Clean box, grease pins on truck.
- Perform basic main pre-trip and post trip inspection.
- Identify basic maintenance.
- Ability to follow directions.
- Identify potential job-site hazards.
- Proper position equipment for operations.
- Must be able and willing to create and maintain a good working relationship with all employees within the team.
- Other duties as assigned.

Education and Experience

- CDL Class B license preferred.
- A willingness to train for CDL Class B is required.

- Must be coordinated to perform job safely and efficiently.

- Must be able to sit in a truck for up to 12 hours a day.
- Must be able to transfer materials ranging from the ground to overhead consistently.
- Must be able to move material up to 75 lbs. frequently.
- Must be able to safely operate a dump truck.
